Ntxiv rau ntawd, nws tseem ceeb yuav tsum nco: **Tsis yog ib tug neeg, lub teb chaws, los haiv neeg twg tsim tus kab mob no—kab mob tsis cais leej twg.**

Peb paub tias tau muaj hais lus phem saib tsis tau ntau zuj zus hauv tsev kawm ntawv los ze tsev kawm ntawv thiab nyob *online* uas tsom peb cov mejyig thiab neeg ua haujlwm yog Esxias (dub hau), *Pacific Islander*, thiab *Desi-American* (khej), tiag yog cov tuaj los zoo li tuaj Suav Teb thiab Esxias Sab Hnub Tuaj tuaj.

Peb qhia tseeb tias txwv tsis pub muaj cov cwj pwm ua phem rau tej haiv los tej pawg neeg hauv UW–Madison—tsis hais txawm peb nyob *online*, dhau lwm tus tej qhov muaj pej xeeb coob, los cais nyob tom tsev.
