

**UHS yuav hno koob tshuaj tiv thaiv COVID-19 rau cov neeg nyob hauv pawg Phase 1a**

*Qhia ntxiv: Lub Ib Hlis xiab 5, 2021, University Health Services pib hno koob tshuaj tiv thaiv tus kab mob rau cov neeg nyob hauv pawg Phase 1a uas yuav hno tau raws xeev thiab nomtsyw tebchaws kev muaj kom ua raws. Cov neeg no yuav tsum tau txais cov emails tuaj ntawm UHS qhia kom teem caij mus hno koob tshuaj thiab xyuas cov caij muaj qhib tas li. Tau muab Moderna ib co tshuaj rau UHS, yog ib koob tshuaj ntawm ob koob uas U.S. Food and Drug Administration tau tso cai raws qhov Emergency Use Authorization.*

MADISON — Wisconsin Department of Health Services tau muab kev pom zoo rau University Health Services pib hno koob tshuaj tiv thaiv COVID-19 rau ib tsoom hauv tsev kawm ntawm uas hno tau koob tshuaj raws qhov kev pab cuam xeev muaj.

Coob tus hauv University of Wisconsin-Madison uas muaj raws li qhov Phase 1a yuav tsum tau txais ib tsab *email* lawm los yuav tau txais sai tuaj ntawm UHS. Qhov xub hno koob tshuaj no yog rau cov ua num rau kuaj mob thiab lwm tus uas tu cov neeg muaj COVID-19, los cov muaj feem ua haujlwm kuaj tus kab mob COVID-19 los kuaj kua nruab nrog txog tus kab mob .

DHS tseem tsis tau qhia UW-Madison tias peb yuav tau cov tshuaj ntawm npaum li cas, los yuav tau cov tshuaj tuaj ntawm lub tuam txhab twg, tabsis cov neeg yuav hno tau koob tshuaj yuav tau txais ib tsab *email* hauv lawv cov *wisc.edu email accounts* qhia ntxiv thaum paub lawm. UW-Madison cov neeg ua haujlwm uas ua num rau hauv tsev kawm ntawm thiab UW Health yuav tsum tau txais ntawm tuaj hauv lawv qhov chaw ua num kuaj mob lawm.

“Peb zoo siab DHS tau muab kev pom zoo rau UHS tam ib qho chaw hno koob tshuaj COVID-19 thiab peb vam yuav hno tau koob tshuaj rau ib tsoom hauv tsev kawm ntaww thaum tau txais cov tshuaj,” Patrick Kelly hais, ib tus kws kuaj mob thiab tus saib xyuas ntawm kev kuaj mob hauv UHS me ntsis. “Peb paub tias yuav yog hli puav ntxiv tag nrho peb cov mejyig thiab neeg ua haujlwm thiaj hno tau koob tshuaj tabsis nov yog ib ruam tseem ceeb thiab muab kev vam rau peb.”

Rau thaum lub Kaum Ob Hlis 2020, lub *Food and Drug Administration* tau muab kev pom zoo siv ob koob tshuaj muaj yuav tsis muaj teeb meem rau lub cev thiab pab tiv thaiv tau zoo raws qhov *Emergency Use Authorization*, pub siv ob koob tshuaj hno tiv thaiv COVID-19. Ob koob puav leej yog [mRNA vaccines](#), uas pab npaj ua kom lub cev paub thiab tua tus kab mob. Kom pab tau zoo tshaj, koob tshuaj *Pfizer-BioNTech* thiab *Moderna* yuav tsum hno ob koob.

Raws lub *Centers for Disease Control and Prevention* hais, qhov cov neeg yuav hno tshuaj coob tshaj qhov muaj cov tshuaj thiab DHS hais tias [nws yuav siv ntau lub hli](#) thiaj yuav hno txhua cov hno tau cov neeg nyob rau qhov *Phase 1a*.

DHS tau tsim cov yuav tsum muaj raws [cov kev ua raws tuaj ntawm federal Advisory Committee on Immunization Practices](#) thiab CDC, nrog rau pawg *Wisconsin State Disaster Medical Advisory Committee*. UW-Madison tab tom nrog DHS xyuas saib leej twg yuav hno tau koob tshuaj rau tom ntej, xws li *Phases 1b* thiab *1c*.

UW-Madison cov mejyig thiab neeg ua haujlwm, nrog rau cov twb hno koob tshuaj lawm, yuav tsum ua raws li cov ruam muaj kom ua tswj kev tus kab mob kis uas npog qhov ncauj qhov ntswg thaum tawm mus lwm qhov, nyob kom sib nrug, txhob mus koom nrog cov neeg tsis nrog nyob ua ke, thiab ntxuav ob sab tes tas li.
