### **Pawg hno tau koob tshuaj tiv thaiv pib lub Peb Hlis xiab 1**

MADISON – Lub Ib Hlis tim 26, [Wisconsin Department of Health Services tau tshaj tawm](#) cov neeg yuav hno tau koob tshuaj tiv thaiv tus kab mob COVID-19 raws qhov *Phase 1b* nyob hauv xeev Wisconsin yog cov twg. Kev hno tshuaj rau cov pawg neeg no pib lub Peb Hlis xiab 1, nyob ntawm saib tshuaj txaus hno rau cov neeg thoob hauv xeev li cas.

Cov pawg neeg hno tau koob tshuaj, raws li cov pawg xub hais nram noua ntej: Cov zov menyuam thiab qhia ntawv (nrog [cov chaw zov menyuam hauv tsev kawm ntawv](#) thiab cov xibfwb thiab neeg ua haujlwm hauv tsev kawm ntawv qib siab [uas ntsib cov mejyig tim ntsej tim muag](#)), cov neeg nyob rau hauv *Medicaid* muaj cov tu, ib co pejxeem ua cov haujlwm tseem ceeb (chaw xa khoom noj haus, chaw ua fais fab los xyuas dej rau pejxeem haus, thiab kho kev kom lag luam mus tau, lwm yam), cov ua haujlwm pab kev tu/kuaj neeg tseem tseeb uas nyob tom qab, cov neeg ua haujlwm saib tej vajtse, thiab cov neeg nyob rau tej qhov muaj neeg coob los sib koom ua ke (tsis yog cov mejyig nyob hauv cov tsev nyob kawm ntawv los *co-op housing*).

UW–Madison yuav siv cov no xyuas muab thiab qhia rau cov neeg nyob hauv tsev kawm ntawv tias lawv hno tau koob tshuaj thiab muab kev qhia lawv cov kauj ruam yuav tau ua mus hno koob tshuaj. Thov saib hauv koj tus *wisc.edu email* rau asthiv puav tom ntej no rau kev qhia ntxiv tuaj ntawm *University Health Services* tuaj.

Lub *U.S. Food and Drug Administration* tau tso cai siv ob koob tshuaj hno tiv thaiv COVID-19 uas kis loj. Ob koob tshuaj, ib koob yog *Moderna* ua thiab koob thib ob yog *Pfizer-BioNTech* ua, tsis muaj teeb meem dabtsi thiab tiv thaiv tau tus kab mob COVID-19 zoo.

UW–Madison yuav hno tshuaj raws nyob ntawm saib muaj tshuaj txaus li cas, nrog rau kev ua raws xeev thaib tsoom fwv muaj, uas leej twg hno tau koob tshuaj thaum twg. Ib co neeg nyob rau cov pawg neeg hais saum no tej zaum yuav xub hno tau yog tshuaj tsawg, raws li DHS xyuas pom.

UHS xav kom txhua tus hno tau koob tshuaj thiab tsis tau hno nyob lwm qhov teem caij thaum qhia rau. Tabsis, yuav tsis yuam kom yuav tsum hno xwb.

Cov neeg xyuas kev noj qab haus huv rau pejxeem hais tias feem coob ntawm cov pejxeem yuav tsum hno koob tshuaj no thiaj yuav txo tau qhov kev kis, tiag yog rau cov yuav mob taus loj. Hno koob tshuaj yuav pab koj tiv thaiv koj tus kheej, koj cov phooj ywg thiab tsev neeg, thiab ib tsoom hauv tsev kawm ntawv ntawm tus kab mob COVID-19.
