

Txog: Raws li tus kab mob kis nqis lawm, kev tsev kawm ntawv kom npog ntaub yuav xaus rau lub Peb Hlis xiab 12

Tsab xov xwm no yog txog:

- *Kev qhia ntxiv txog kom npog ntaub hauv tsev kawm ntawv*
- *Cov kev pab tseem ceeb*

Tshua txog cov mejig, xibfwb thiab neeg ua haujlwm,

Nyob rau lub Ob Hlis xiab 14, *Public Health Madison & Dane County (PHMDC)* [tau tshaj tawm tias](#) qhov *Dane County* yuav tsis kom npog ntaub thaum nyob sab hauv tsev tom qab lub Peb Hlis xiab 1 lawm. Ua tsaug rau qhov tus kab mob COVID-19 kis nqis ntxiv nyob hauv thiab tawm sab nraum tsev kawm ntawv, UW-Madison kuj yuav tsis kom npog ntaub thaum nyob hauv tsev ntxiv lawm.

Qhov tsev kawm ntawv kom npog ntaub tam sim no yuav muaj txog lub Peb Hlis xiab 11 kom muaj zoo tib yam txog thaum xeem ntawv ib nrab rau lub caij kawm. Pib lub Peb Hlis xiab 12, hnub pib lub Caij So rau Caij Ntuj Tshiab, yuav tsis kom npog ntaub thaum nyob hauv tsev lawm.

Tseem yuav kom npog ntaub ntxiv thaum caij *Madison Metro* cov npav, raws tsoom fwv teb chaws kom ua. Cov chaw ntsib thiab kuaj mob, zov menuam, thiab npaj zaub mov noj tej zaum tseem yuav kom npog ntaub ntxiv.

Muaj cov zej zog thiab tsev kawm ntawv qib siab ntau lub tau tshem qhov kom npog ntaub vim qhov tus kab mob COVID-19 kis nqis thiab cov neeg tau pw tsev kho mob nqis tsawg lawm thiab cov koob tshuaj hnob ntxiv kuj pab kom txhob mob loj. Txawm qhov no tsis thwm tias tus kab mob dhau lawm los, nws yog ib qho ua rau peb ntseeg tias koob tshuaj hno tiv thaiv COVID-19 pab tau peb.

Kev tshawb fawb qhia tau zoo tias cov tib neeg hno tshuaj puv lawm, hno koob hno ntxiv, thiab npog cov ntaub tiv thaiv tau zoo, tsis hais lwm tus nyob ze lawv txiav txim ua li cas. Qhov no thwm tau tias peb nyob rau qhov ib tug neeg nws txiav nws txim yuav coj tus cwj pwm zoo li cas los tau.

Peb pom tias cov neeg yuav coj txawv rau qhov tsis kom npog ntaub lawm thiab yuav muaj kev nyuaj siab rau ib txhia. Peb cuab zog kom cov tseem xav npog ntaub npog ntxiv thiab peb yuav muaj cov ntaub npog tau zoo dawb ntxiv rau ib tsoom hauv tsev kawm ntawv. Thov hwm qhov txhua tus neeg xaiv ua txog npog ntaub los tsis npog.
