

Txog: **Kev txhawb rau ib tsoom Esxias thiab APIDA thiab qhia ntxiv txog hauv tsev kawm ntawv**

Tsab xov xwm nram no tuaj ntawm University of Wisconsin–Madison tus Interim Chancellor John Karl Scholz tuaj

Rau peb ib tsoom hauv tsev kawm ntawv –

Txog tam sim no, nej coob tus yuav hnov txog cov kev ua phem thiab ntaus lwm tus uas tshuam rau *University of Wisconsin–Madison* cov meyig thiab raug rau coob leej hauv tsev kawm ntawv, tiag yog peb cov neeg yog Esxias, *Pacific Islander thiab Desi American (APIDA)* thiab lwm tus uas yog Esxias.

Kuv qhia rau nej tias *UW–Madison* thiab lub *UW Police Department* nrog *Madison Police Department* xyuas txhawb cov raug teeb meem thiab kom to taub tias tau muaj li cas. Tsis pub muaj kev ua phem nyob hauv peb lub tsev kawm ntawv, los nyob hauv peb lub nroog, thiab peb yuav xyuas kom muaj kev nyabxeeb rau ib tsoom.

Kuv kuj xav qhia ntxiv txog qhov teeb meem raws li tam sim no peb to taub, qhia rau ib tsoom tias tsev kawm ntawv ho tab tom ua li cas pab — uas muaj cov lus cov meyig thiab cov thawj coj ntawm cov meyig muab, thiab muab kev txhawb thiab pab rau peb cov meyig thiab neeg ua haujlwm.

Rau thaum ob hnub so tas los, [Madison Police tau ntes plaub tus neeg ua phem](#) uas txuam nrog cov kev ua phem muaj tsis ntev los no hauv plawv nroog, nrog rau qhov ntaus tus meyig nyob hauv thaj chaw tsev kawm ntawv UW–Madison uas yog asthiv tas. *Madison Police* taus hais tias cov neeg ua phem no tsis yog kawm ntawv los ua haujlwm nyob hauv thaj chaw tsev kawm ntawv.

Ob qho kev ua phem no, uas muaj rau thaum lub Rau Hli xiab 14, yog ua rau cov meyig uas yog Suav. Ib tug yog tus meyig kawm ntawv yog *graduate student* qhia rau *Madison Police Department* tias ib pab neeg tau ntaus nws thaum nws taug kev nyob pem plawv nroog. Tus ob yog ib tug meyig tseem kawm rau plaub xyoos qhia rau *UWPD* tias ib pab neeg txawb txiv tsawb rau nws. Tom qab nws qhia rau *UWPD*, nws kuj hais tias nws raug mob los ntawm qhov teeb meem no, uas tsis muaj nyob rau hauv sob lus muab rau tsev kawm ntawv hnub Zwj Kuab.

Rau ob hnub so tas los, *Madison Police* qhia rau cov thawj hauv tsev kawm ntawv tias muaj ib qho sib ntaus nyob hauv plawv nroog thaum lub Rau Hlis xiab 12 uas muaj ib tug txiv neeg dawb tsis kawm ntawv los ua haujlwm nyob hauv tsev kawm ntawv thiab ib tug txiv neej *Hispanic* tseem kawm rau plaub xyoos uas nws raug mob tau mus ntsib tsev kuaj mob. Ntseeg tias cov ntaus tus no yog tib co neeg. *Madison Police* kuj qhia tias qhov raug ntaus thib plaub, uas tus raug ntaus tsis kawm ntawm los ua haujlwm nyob hauv *UW–Madison*.

Tom qab cov teeb meem no, *UWPD* thiab *Madison Police* muaj cov neeg ua haujlwm ncig tas li coob nyob ntawm thaj chaw plawv nroog. Ob qho chaw saib kev ruaj ntseg no sib koom xyuas kom pom muaj cov tub ceev xwm tas li raws qhov *Downtown Safety Initiative*.

Cov tub ceev xwm kuj tsis tau paub tseeb tias cov kev ua phem no yog vim li cas, tabsis cov neeg xwj tseem tab tom xyuas muab qhov tseeb thiab yog lawv pom tias yog kev ntxub ntxaug ua, lawv yuav muab tso rau qhov ntawd.

Cov thawj coj cuab txhua tus zog tias yog leej twg tau raug kev ua phem *kom hu rau UWPD* (nyob hauv thaj chaw tsev kawm ntawv) los *City of Madison Police Department* (yog tawm sab nraum thaj chaw tsev kawm ntawv), lub *Dean of Students Office* los, cov neeg ua haujlwm hu rau, *lub Office of Compliance*. Tsev kawm ntawv muaj kev txhawb thiab cov chaw pab cov mejyig qhia cov teeb meem rau tub ceev xwm los teeb daim ntawv *qhia kev ntxub ntxaug* rau tsev kawm ntawv.

Qhov teeb meem no thiab ib co kev peb tau ua pab ua rau muaj kev txhawj, raug mob thiab tsis txaus siab ntawm peb cov neeg Esxias thiab *APIDA* nrog rau cov neeg pab peb. Rau ib co, nws tau ua rau lawv ntshai thiab txhawj. Tau tshaj ob xyoos los lawm, cov neeg Esxias thiab *APIDA* nyob hauv U.S. thiab hauv qab ntuj tau raug hais lus saib tsis tau, ua phem rau, ua kom ntshai thiab ntaus. Cov teeb meem no muaj nyob hauv Madison tib yam.

Peb paub tias yuav tau muaj kev pab kom txhob muaj qhov kev ua phem thiab muab caij rau cov neeg xyuas kho. **Rau pib qhov kev pab txog cov kev ua phem ntaus, *University Health Services* muaj ob qho caij sib tham txhawb, nyob hauv computer rau cov mejyig uas yog Esxias thiab *APIDA*.** Thawj qhov *tau teem rau thaum 5 teev tsaus ntuj lub Rau Hlis tim 20* thiab qhov thib ob *yuav muaj rau lub Rau Hlis tim 21 thaum 4 teev tsaus ntui*.

Thov nco tias peb yuav nrog peb cov mejyig, neeg ua haujlwm, thiab xibfwb; cov muaj feem koom nrog peb hauv Madison; thiab tub ceev xwm xyuas kom peb kev sib pab ua tau yog ib qho chaw muaj kev nyabxeeb, rub sawv daws ua ke thiab txhawb txhua tus nyob hauv tsev kawm ntawv.
