- Cov khoom kuaj *antigen* rau COVID-19 dawb [yuav muaj ntxiv](#) rau tag nrho cov mejiyig thiab neeg ua haujlwm nyob ntawm *333 East Campus Mall*. Yuav tsis muaj kuaj *antigen* tom qab lub Kaum Ob Hlis tim 23 thiab rov muaj kuaj dua rau lub Ib Hlis xiab 3, 2023.
- Lub *Wisconsin Department of Health Services* kuj muaj ib qho kev pab uas pub cov tsev neeg [teev ntawv kom xa cov khoom kuaj dawb txhua hli](#) uas muaj 5 qho uas kuaj qhia paub tam sim.
- Kev kuaj *PCR* rau COVID-19 yuav muaj txog thaum lub caij kawm ntuj tsaug xaus. Pib 12/26/2022, yuav tau mus ntsib kuaj ntawm ib qho chaw kuaj mob los ib qho [chaw kuaj tawm sab nraum tsev kawm ntawv](#). UW–Madison cov mejiyig muaj cim mob thiab yuav tau ntsib chaw kuaj mob [teem tau ib lub caij nrog University Health Services](#). Nrog qhov kev pauv kuaj *PCR*, qhov *COVID-19 dashboard* kuj yuav tsis muaj ntxiv lawm. Cov pauv no muaj raws li *Public Health Madison and Dane County (PHMDC)* hloov thiab lwm lub tsev kawm ntawv qib siab hauv lub teb chaws.

- Hno tshuaj yog ib qho tiv thaiv tau zoo tshaj kom txhob mob los txo qhov mob taus loj.

Ntaub Npog Qhov Ncauj Qhov Ntswg

- Npog ntaub yog ib qho yooj yim thiab pab tiv thaiv tau zoo kom txhob kis cov kab mob ua rau ua tsis taus pa, xws li COVID-19, kab ua npaws thiab *respiratory syncytial virus (RSV)*.
- Raws qhov tseem tshuav, tsev kawm ntawv yuav muab cov khoom kuaj dawb rau cov mejiyg thiab neeg ua haujlwm nyob ntawm tsev kawm ntawv cov chaw nqa.
