

**Tuaj ntawm: Office of Strategic Communication**

**Rau: Cov mejyig, xibfwb thiab neeg ua num**

**Txog: UW tus cai hloov txog kev ua los hais raws xav hauv tsev kawm ntawv, nthuav cov kev pab ntxiv rau kev kawm thiab ib tsoom**

**Hnub: Yim Hli tim 28, 2024**

University of Wisconsin–Madison tau muab los tso ua ke thiab qhia kom tseeb txog tsev kawm ntawv tus cai xyuas kom ua los hais tau tawm li xav, ib qho kev saib muaj nqi ntawm UW, tseem yog ib qho tswj tiv thaiv hauv tsev kawm ntawv thiab xyuas tuav lub zeem muag tseem ceeb thiab kev khiav haujlwm, xws li kom cov mejyig muaj peev xwm kawm tau ntawv tsis muaj kev tshuam cuam.

Tus cai muaj npe tshiab hu ua *Expressive Activity Policy* thiab nrog kev qhia muab tag nrho cov cai thiab kev ua raws thooob plaws hauv tsev kawm ntawv los tso ua ke, thiab muab kev qhia kom tseeb tshiab rau cov mejyig, neeg ua num thiab cov qhua tuaj saib tsev kawm ntawv. Tus cai thiab qhov kev qhia ua raws tsim pab kom cov mejyig, neeg ua num thiab qhua to taub zoo txog lawv muaj cai thiab lawv cov luag haujlwm yog li cas.

Qhov no yog ib qho ntawm qhov kev qhia ib tsoom hauv tsev kawm ntawv txog tag nrho cov kev ua los hais tawm li xav, qhia ncaj, thiab nthuav kev pab tib neeg txiav txim ua los hais tej yam. Lub hom phiaj yog xyuas kom muaj taus cov kev tseem ceeb hauv lub tsev kawm ntawv — nrhiav nug kom paub, tshawb fawb kawm, muaj kev pab, qhia thiab kawm — mus taus txhob nres.

“Qhov kev sib qhia tswv yim thiab kev pom yog tseem ceeb rau ib lub tsev kawm ntawv. Nws yog ib qho tseem ceeb ntawm ib lub tsev kawm ntawv muaj npe kev ua, los yuav tau ua, txhua hnub, thiab nws yog qhov peb xyuas, nyob hauv UW–Madison, thaum peb tham txog kev ywj pheej tsis ntshai tshawb qhov tseeb kawm. Nws thwm tau tias peb yuav koom nrog tej qhov tswv yim thiab kev pom uas yog tshiab rau peb, thiab tej zaum nws, rau tej zaum, ua rau peb tsis xav ua los hais,” s *Chancellor* Jennifer L. Mnookin hais. “Kuv vam tias, tam ib tug hauv tsoom Badger, peb yuav qhib peb lub siab dav xyuas, mloog lwm tus, ib tug hwm ib tug, thiab pab kom tshaj qhov peb ua tau.”

## Cov Cai thiab Kev Qhia Ua Raws

Qhov tsev kawm ntawv xyuas ua raws txog cov kev ua los hais tawm muaj nyob hauv ob tsab ntawv qhaib no. Qhov ib, tus cai [Expressive Activity Policy](#), muaj — cov lus cai lij choj — raws qhov *First Amendment* pub muaj thiab nws txwv txog dab tsi raws lub caij, qhov chaw thiab raws qhov ua los hais tawm uas lub tsev kawm ntawv tsim.

Qhov ob, qhov kev qhia ua raws, [Expressive Activity Guide](#), yog ib qho siv tau yooj yim uas nthuav dav txog kev ua raws rau ntau yam. Nws muaj cov piv txwv pub thiab tsis pub muaj li cas, nrog rau kev qhia thiab pab npaj ua tej yam dab tsi thiab cov kev kwv paib uas kom raws tus cai thiab cov tib neeg ua tau (thiab tsis tau) yog lawv pom tias qhov ua los hais tawm saib tsis taus lawv.

Tus cai txhawb thiab ua kom paub zoo tias tej yam ua los hais tawm pub muaj sab nraum zoov ntawm lub tsev kawm ntawv, yuav tsum muaj caij, raws cov kev pub thiab chaw ua. Cov kev pub ua li cas no ua kom tag nrho cov laj mej thiab ib tsoom hauv tsev kawm ntawv siv tau cov chaw thiab txhawb kev nyab xeeb thiab khiav tau tsev kawm ntawv cov dej num, xws li cov mejiyig muaj peev xwm kawm tau ntawv thiab cov kws qhia ntawv qhia tau txhob muaj kev cuam tshuam.

Cov kev pauv rau tsev kawm ntawv cov cai tam sim no muaj xws li, tab tsis tsis tas li, cov nram no xwb:

- Kev ua los hais txog tej yam txwv tsis pub ze tshaj 25 kauj ruam ntawm tsev kawm ntawv cov tsev los lawv yog tus saib cov qhov rooj nkag. Tej zaum *University of Wisconsin Police Department* kuj yuav nce qhov deb li cas no kom tiv thaiv tau cov tib neeg kev nyab xeeb los tsev kawm ntawv tej vaj tse.
- Cov paib siv rau hauv tsev yuav tsum tsis pub loj tshaj 3 kauj ruam tov (*time*) 3 kauj ruam. Cov paid yuav tsum yog siv tes tuav kom raws li tus cai los txwv tsis pub siv pas los dab tsi txawb cov paib rau.
- Suab ncha thwm tias yuav nrov tshuam lwm tus thaum nws nrov tshaj 85 *decibels* nyob ib thaj chaw hauv tsev deb tshaj 50 kauj ruam los tshaj, ntshe ho tau cai ua ntej los ib yam yog tsev kawm ntawv ua xwb.
- Paj taub tes tuav, siv roj teeb hais kom nrov (xws li *Bluetooth* lub paj taub me me los *bullhorns*) tam sim no pub siv tsis tas tau kev tso cai ua ntej, tab sis tsis yog rau thaum kawg

los siv ua kom nrov cuam tshuam lwm tus. Raws tus cai, tag nrho cov siv ua kom suab nrov, txawm yog rau ib qho npaj ua ntej los cia li muaj, yuav tsum tau kev tso cai.

- Tej thaj chaw nrov npe nyob hauv tsev kawm ntawv muaj cov cai txawv rau kev siv ua los hais tej yam tawm. Rau piv txwv, cov tib neeg yuav thaiv tsis tau qhov mus rau ntawv tus *Abraham Lincoln statue* saum Bascom Hill los txwv tsis pub lwm tus thaj duab ntawm tus *statue* thaum lub asthiv pib kawm ntawv lub caij ntuj tsaug thiab lub asthiv thaum lub caij xaus lav ntawv tag. Muaj cov kev txwv tsis pub thaiv hauv taw roob Bascom Hill rau lub caij lav ntawv tas.

Tsev kawm ntawv yuav tsis tuaj tog twg – uas, nws yuav tsis xyuas tias qhov kev pom ua los hais tawm yog li cas thaum siv tus cai no.

### **Kev muaj caij kawm**

Qhov kho tus cai no sawv cev ntawm ntau kauj ruam lub tsev kawm ntawv tau ua kom muaj qhov kev ua los hais tau li xav thiab txhawb kom muaj qhov cov neeg ho xav tias lawv yog ib tug nyob hauv lub tsev kawm ntawv. Lwm cov kauj ruam:

- Qhov [Free Expression at UW–Madison module](#) tshiab muaj cov qhia zoo xws li kom ua tshaj li qhov ua tau pab, muaj kev kawm los qhia ntawv yooj yim, kev hais saib tsis taus lwm tus, thiab kwv paib raws kev muaj cai raws qhov *First Amendment*. Txawm tsuas kom cov mejyig tuaj thawj xyoo thiab pauv lwm los kawm xwb los, cuab zog kom tag nrho ib tsoom hauv tsev kawm ntawv saib cov nyob hauv lub [university's free expression site](#).
- Cov neeg ua num thiab mejyig muaj lus nug txog kev koom pab khiav ua nom tswv thiab txhawb pejxeem nyob hauv tsev kawm ntawv nrhiav cov lus teb tau hauv [Political activity and activism on campus: Guidelines for fall 2024](#).
- Tsev kawm ntawv tau muaj qhia kom tseeb ntxiv rau Mejyig Cov Koos Haum Tso Npe {*Registered Student Organizations (RSOs)*} txog kev ua raws thiab yuav tsum tau ua dab tsi nyob hauv daim [conduct process for student organizations](#). Ntxiv, tam sim no txhua lub Koos Haum Tso Npe yuav tsum muaj ib tug pab muab tswv yim (*adviser*) pab kom lawv ua cuag lawv cov homphiaj. Yuav muaj kev pab rau cov Koos Haum Tso Npe uas xav tau kev pab

nrhiav ib tug muab tswv yim. Lub *Center for Leadership and Involvement* yuav muaj kev txhawb rau cov neeg pab tswv yim uas yog nthuav lawv cov kev cob qhia thiab txhawb cov neeg pab tswv yim.

- Lub tsev kawm ntawv cov thawj coj tau nrog cov pawg neeg ntawm cov mejiyig, xibfwb thiab neeg ua num tsim tus cai kom qhia tau zoo thiab zoo sib xws qhia txog thaum lub tsev kawm ntawv siv nws lub suab hais los sawv cev rau ib qho teeb meem. Tus cai no tej zaum yuav kho tiav rau lub Cuaj Hlis xiab.
