**Kev Qhia Ua Raws txog Tsoom Fwv Tshawb Neeg Muaj Ntaub Nkag Teb Chaws Li Cas**

UW-Madison txhawb kom tswj tuav tau kev nyab xeeb thiab yog ib qho chaw rub ua ke coj tsev kawm ntawv cov zeem muag rau kev khiav haujlwm thiab qhia ntawv, tshawb fawb kawm thiab mus cuag tawm sab nraum — xws li kom cov mejyig muaj peev xwm kawm tau ntawv — tsis muaj kev cuam tshuam.

Tsev kawm ntawv ua kom yog ib qho chaw tiv thaiv tau txhob paub cov mejyig, xibfwb, thiab neeg ua haujlwm yog leej twg thiab lawv muaj cai raws tus cai lij choj.

Tsev kawm ntawv tsuas muab ntaub ntawv qhia muaj ntawv li cas tuaj teb chaws li cas txog nws cov mejyig, xibfwb, thiab neeg ua num yog tus cai lij choj kom muab nkaus xwb.

**Kuv yuav hu rau leej twg thaum muaj ib qhov xwm txheej ceev?**

Thaum muaj ib qhov xwm ceev, ntaus 911 los hu UWPD rau (608) 264-2677.

**UWPD muaj feem li cas soj xyuas raws tsoom fww cov cai lij choj txog muaj ntaub ntawv li cas nkag teb chaws?**

UWPD nws muaj nws ib co kev ua raws thiab siv qhaib raws tsoom fww kev soj xyuas muaj ntaub ntawv li cas nkag teb chaws, thiab nws cov tub ceev xwm yuav tsis tuav los ntes ib tug neeg raws qhov hla tsoom fww tus cai lij choj muaj ntaub ntawv nkag teb chaws nkaus xwb thiab yuav tsis nug txog tus tib neeg muaj ntaub ntawv li cas.

**UWPD puas yuav koom nrog tsoom fww kev soj xyuas muaj ntaub ntawv li cas nkag teb chaws?**

Tsis koom. UWPD yuav tsis koom nrog tsoom fww kev soj xyuas muaj ntaub ntawv li cas tuaj. Tsoom fww cov neeg yuav tsum siv kev ua raws li tus cai lij choj yog lawv tuaj hauv tsev kawm ntawv thiab xav ntsib cov neeg txog soj xyuas muaj ntaub ntawv li cas.

**Qhov muaj ntaub ntawv li cas tuaj puas tshuam kev UWPD xyuas kom muaj kev nyab xeeb rau pej xeeb?**

Tsis tshuam. Ib tug neeg muaj ntaub ntawv li cas nkag teb chaws tsis yog qhov qhaib rau UWPD xyuas pab kom muaj kev nyab xeeb rau hauv tsev kawm ntawv thiab ib tsoom thiab tsuas siv yog tias ua txhaum ib yam cai loj xwb. Qhov tus neeg muaj ntaub ntawv li cas tsis tshuam nws kev muaj peev xwm teev ntawv los qhia UWPD kom pab.

**Tsev kawm ntawv puas siv qhov *WiscAlerts* los lwm yam qhia yog/thaum pom muaj tsoom fww tuaj soj xyuas hauv tsev kawm ntawv?**

Tsev kawm ntawv tsis siv qhov *WiscAlerts* — UW–Madison qhov kev qhia xwm txheej ceev tas li — rau qhia yog muaj tsoom fww los lwm tus neeg tuaj rau hauv tsev kawm ntawv.

Tsoom fww tus cai lijchoj thiab cov cai tswj txhais pub siv *WiscAlerts* qhia tau dab tsi xwb.

Cov siv tau qhov *WiscAlerts* xa muaj xws li: muaj neeg yuav ua raug lwm tus (xws li muaj neeg yuav tua lwm tus), muaj tej yam tshuaj tsis zoo nchuav ntau thiab yuav muaj kev phom sij loj, kaw ib koog hauv tsev kawm ntawv, muaj kev tshuam loj tsev kawm ntawv kev ua haujlwm, kaw ntau lub tsev, muaj neeg raug mob coob los tab tom muaj ceeb toom cua khaub zig yuav raug hauv tsev kawm ntawv.

Siv qhov kev tshaj qhia no rau lwm yam tus cai lij choj tsis pub siv thiab tsis ua raws tsev kawm ntawv tus cai tej zaum yuav raug tsoom fww xwj thiab nplua nyiaj ntau.

Yog muaj ib qho xwm txheej uas yog ib qho yuav puas kev noj qab haus huv los kev nyab xeeb ntawm cov mejyig los cov neeg ua num hauv tsev kawm ntawv, tej zaum yuav siv *WiscAlert*.

### **Kuv puas yuav hu UWPD yog kuv pom tsoom fww cov neeg hauv tsev kawm ntawv?**

Pom, los muaj tsoom fww cov neeg ntes neeg hauv tsev kawm ntawv tsis yog ib qho hu tau 911 los UWPD tus xovtooj tsis yog xwm ceev ntshe ho muaj cov nram no xwb:

- Yuav tsis muaj kev nyab xeeb rau koj los lwm tus
- Nws muaj neeg ua tsis raws cai los yuav muaj kev ua phem
- Tab tom muaj neeg tsoo tsev los khoom

### **Kuv yuav hu tau leej twg yog muaj tsoom fww ib tug neeg ceev xwm tuaj ntsib kuv hauv tsev kawm ntawv los chaw ua haujlwm?**

Yog muaj tsoom fww ib tug neeg tuaj ntsib koj hauv tsev kawm ntawv los chaw ua haujlwm, hu lub *Office of Legal Affairs* rau (608) 263-7400 thiab thov nrog ib tug kws lij choj hauv tsev kawm ntawv tham. Muaj neeg teb lub *OLA office* tus xovtooj 24/7. *OLA* yuav qhia tam sim rau UWPD. Muaj kev qhia ntiv txog cov kev sib tham no rau koog nram qab no.

### **Rau tawm tsev kawm ntawv sab nraum, cov cai *Madison Police Department* ho ua raws tsoom fww kev soj ntsuam muaj ntaub ntawv muaj li cas?**

*Madison Police Department* hais tias “ib tug tib neeg muaj ntaub ntawv nkag teb chaws li cas tsis tseem ceeb rau *MPD* sob lus lub zeem muag, sob lus lub hom phiaj, cov kev muaj nqi, thiab kev khiav haujlwm. Kev muaj ntaub ntawv li cas nkag teb chaws tsuas tseem ceeb thaum ib tug tub ceev xwm ntseeg tias tus neeg ntawd tau ua ib qho txhaum cai log uas tshuam rau pej xeem kev nyab xeeb nkaus xwb.” *MPD* tso li no hauv nws cov cai txog qhov teeb meem no.

### **Tsoom fww cov neeg tuaj tau li cas rau hauv thaj chaw kawm ntawv**

### **Tsev kawm ntawv txwv puas tau tsis pub tsoom fww cov tub ceev xwm tuaj rau hauv thaj chaw kawm ntawv?**

Tiag, tsis tau. Tab sis, tsoom fww cov neeg tsuas mus tau rau ntawm cov chaw pej xeem mua tau xwb, yuav tsum muaj tsev hais plaub daim ntawv tso cai thiaj mus tau rau lwm thaj chaw txwv.

### **Kuv yuav ua li cas yog muaj tsoom fww ib tug neeg tuaj rau hauv cov tsev kawm ntawv los chaw ua haujlwm?**

Nws muaj ntau kauj ruam koj ua tau, raws li hauv no.

- Coj txias txias thiab ua twb zoo hais. Siv caij ua tib zoo xav koj cov lus yuav teb.
- Nug tus neeg lub npe thiab saib nws daim npe koj. Feem ntau tus neeg yuav tsum muab nws lub npe tsis nug dab tsi. Yog tsis muab, nws yog koj kev muaj cai nug.
- Xyuas tus neeg npe thiab daim npe ua haujlwm kom tseeb thiab nug vim li cas nws ho tuaj rau hauv tsev kawm ntawv, yog nws tsis tau qhia.
- Hais kom tus neeg zaum ntawm qhov chaw tos los nkag los hauv tsev tos. Yog koj tsis muaj qhov chaw nyob tos, ua twb zoo hais kom nws nyob tos koj mam hu tus neeg nws yuav ntsib.
- Hu lub *Office of Legal Affairs* rau 608-263-7400 thiab nrog ib tug kws lij choj tham. Muaj neeg teb lub *OLA office* tus xovtooj 24/7. Hais li nram no qhia tus kws lij choj: “Tus neeg (npe) tuaj ntawm ceg ua haujlwm npe tuaj nov yuav nrog koj tham txog (tus neeg npe) [*Agent X from the Department of Y is here to talk to you about Z*].” Txhob hais lus tseg rau *Legal Affairs*, mloog thiab xaiv ib qho muaj neeg teb.
- Yog tsis muaj neeg hauv lub *Legal Affairs* khoom, qhia rau tus neeg tias tsis muaj neeg khoom tam sim no. Hais kom nws rov tuaj dua lwm lub caij.
- Txhob pub tus neeg no saib tej ntaub ntawv los qhib ib lub *computer*. Cov neeg no mus tau rau txhuas thaj chaw pej zeem mus tau rau ntawm chaw ua haujlwm tab sis yuav tsum muaj ntawv los ntawm tsev hais plaub thiaj nkag tau thej thaj chaw txwv.

### **Ib tug mejiyig ua haujlwm yuav ua li cas yog muaj tsoom fww cov neeg tuaj?**

Yog tsoom fww ib tug neeg tuaj ntsib ib tug mejiyig ua num, tus mejiyig yuav tsum mus hais nws tus thawjsaib tam sim. Yog nws tus thawjsaib tsis nyob, tus mejiyig yuav tsum hu rau ceg num ib tug *HR representative*. Tus thawjsaib thiab/los ceg num tus *HR representative* mam los nrog tus neeg ntawd tham. Rau kom qhov no mus taus, tag nrho cov ceg ua num yuav tsum muaj daim muaj cov neeg mus hais tau rau no.

### **Yuav muaj li cas thaum kuv hu lub OLA? Puas muaj ib tug sawv cev hauv OLA nrog tsoom fww tus neeg tham?**

Tus kws lij choj yuav nug tus neeg hu kom piav qhov tuaj ntawd thiab ntsuam xyuas daim ntawv tso cai los lwm yam ntawv cai lij choj uas muab rau tus neeg ua haujlwm.

### **Yuav ua li cas yog tsoom fww tus neeg tsis ua li kuv hais?**

Yog tus neeg ntawd tsis mloog li koj hais los thov, txhob cheem cov nws ua.

Yog tus neeg ntawd ua — tos los tsis tos kev qhia ntawm koj los lwm tus hauv tsev kawm ntawv thiab txawm muaj ntawv tsev hais plaub tso cai los tsis muaj — nws tseem ceeb koj tsis txhob cheem los thaiv kev, vim thaiv kev los ua lwm yam cheem tej kev tub ceev xwm ua yog ib qho txhaum.

## **Cov chaw pej xeem mus tau los tsis tau rau**

### **UW cov chaw ua haujlwm twg pej xeem mus tau rau?**

Tsoom fvv cov neeg mus tau rau txhua qhov chaw ua num pejxeem mus tau rau tab sis yuav tsum muaj ntawv tso cai mus rau ib qho chaw pej xeem mus tsis tau. Cov neeg ua num hais tau rau tus neeg tias, “Kuv tso tsis tau cai rau nkag rau los txais tsis tau cov ntawv lij choj,” thiab hu rau lub *Office of Legal Affairs* li qhia saum no.

### **Dab tsi yog ib qho chaw pej xeem mus tau rau?**

Tam li ib lub tsev kawm ntawv yog pej xeem tug, muaj ntau thaj chaw hauv tsev kawm ntawv thiab nws cov vaj tse qhib rau pej xeem. Tiag, txoj cai lij choj pub tsoom fvv cov tub ceev xwm nkag tau rau cov chaw pej xeem mus tau rau tsis tas tau kev tso cai. Cov chaw pej xeem mus tau rau muaj xws li cov kev taug; tej qhov muaj nroj/nyom ntsuab, cov chaw nres tsheb; thiab chaw nkag rau hauv lub tsev, nyob tos, los kev taug hauv lub tsev uas qhib rau pej xeem. Tsev kawm ntawv cov tsev cia ntawv thiab *museums* uas qhib rau pej xeem kuj yog chaw pej xeem nkag tau rau. Tsev kawm nawv tej yam muaj ua, xws li kev piav qhia, sib tham thiab ua yeeb yam uas muaj dawb thiab qhib rau pej xeem, los caij sib tham raug *Wisconsin Open Meetings* tus cai lij choj, kuj thwm tias chaw pej xeem nkag tau rau.

### **Dab tsi yog cov chaw txwv tsis pub pej xeem nkag?**

Tsev kawm ntawv ib co chaw, xws li cov xibfwb, neeg ua num thiab mejyig cov chaw ua haujlwm; cov tsev nyob kawm ntawv; chav tshawb fawb kawm; thiab cov chaw yuav tau siv yawm sij los daim *card* qhib, tsis qhib rau pej xeem yog tsis tau cai tso nkag.

Cov chaw kawm ntawv los mus tsis tau rau yog tseem muaj qhia ntawv nyob hauv, ntshe chaw ntawd ho ua tej yam qhib rau pej xeem xwb. Lwm qhov chaw mus tsis tau muaj xws li cov chaw muaj rau neeg ua num los lwm tus yuav tsum muaj tus coj nkag nkaus xws, cov chaw yuav tsum muaj pib nkag, cov chaw muaj rau cov neeg tuaj ntsib kuaj mob los koom kev tshawb fawb kawm, tsev kawm ntawv los neeg ua num cov tsheb; thiab lwm qhov chaw uas tsis pub twg pom los paub.

Tiag, tsoom fvv cov tub ceev xwm yuav nkag tsis tau cov chaw txwv yog tsis tau kev tso cai, ntshe ho muaj daim ntawv tso cai pub tshawb los yuav tsum tau ua los pab tam sim xwb.

### **Dab tsi qhia tau tias yog daim ntawv tso cai tseeb pub nkag los tshawb?**

Ib daim ntawv tseeb pub nkag los tshawb yuav tsum muaj tus neeg txiav txim hais plaub lub npe kos thiab tso hnuv rau. Nws kuj muaj lub caij uas pub nkag los tshawb, piav qhia tias yuav tshawb dab tsi, thiab cov khoom yuav tshawb thiab muab tau (xws li ntaub ntawv them nyiaj, tus neeg ua num cov ntaub ntawv, thiab lwm yam).

### **Kuv lo puas tau cov paid hais tias “PRIVATE” los “UNIVERSITY PERSONNEL ONLY” los lwm yam qhaib rau cov chaw los qhov rooj ntawm kuv lub tsev?**

Tsev kawm ntawv tab tom xyuas cov chaw pej xeeb nkag tau thiab tsis tau thiab yuav qhia ntxiv rau sawv daws thaum paub tias yuav ua li cas.

Tsuas yog tsev kawm ntawv cov neeg muaj cai xws li *Facilities Planning & Management* thiab/los cov thawj saib lub tsev ntawd thiaj muaj cai lo cov paib no rau sab hauv cov tsev hauv thaj chaw kawm ntawv xwb. Tsis pub tiv cov paib no sab nraum cov qhov rooj nkag los hauv cov tsev.

### **Ib tug mejiyig tsis pub tsoom fww cov tub ceev xwm nkag rau hauv lub tsev nyob kawm ntawv puas tau yog tsis muaj daim ntawv tso cai nkag los tshawb?**

Tau. Ib chav hauv lub tsev nyob kawm ntawv thwm tias ib qho chaw txwv thiab tsoom fww cov tub ceev xwm nkag tsis tau yog tsis muaj daim ntawv tso cai nkag los tshawb, yog kev yeem ntawm tus nyob hauv, los raws ib qho kev yuav kom pab tam sim. Ib tug mejiyig tsis tas tso cai rau ib tug tub ceev xwm yog tsis muaj daim ntawv tso cai nkag los tshawb.

### **Lub *Office of Legal Affairs* sawv puas tau cev ntawm cov tib neeg rau tej cai lij choj?**

Tsis tau. *OLA* sawv cev ntawm lub tsev kawm ntawv, xws li cov neeg uas khiav tsev kawm nawv cov dej num. *OLA* sawv tsis tau cev rau cov xibfwb, neeg ua num los mejiyig rau lawv txog tej cai lij choj rau lawv cov dej num tawm sab nraum tsev kawm ntawv. Cov tib neeg xav tau kev pab txog cai lij choj hu tau *State Bar of Wisconsin Lawyer Referral and Information Service* rau (608) 257-4666 los (608) 257-3838.

### **Kev qhia ntxiv txog tsis pub leej twg paub**

### **UWPD siv nws cov koob thaj *Flock Safety* rau dab tsi?**

UWPD siv nws cov koob thaj *Flock Safety* tsom cov paib tsheb txhawb nws lub zeem muag tseem ceeb kom tswj tau kev nyab xeeb rau ib tsoom hauv tsev kawm ntawv.

Cov koob thaij tau duab xwb no yog tsim los txhawb tswj kev tub sab tub nyiag thiab pab WUPD kev xwj kom muab tau ceev txog tej tsheb uas ua teeb meem loj, xws li *Amber Alerts*, kev ua phem heev, nyiag tsheb, thiab neeg ploj lawm. Cov koob thaij no tsom xyuas ntaub ntawv txog cov tsheb — tsis yog cov tib neeg. Cov koob thaij no tsuas thaij daim paid tsheb thiab seb lub tsheb zoo li cas xwb, nyob rau cov chaw pej xeeb mus tau tas li. Nws qhia tsis tau tus neeg tsav tsheb los cov caij, thiab tsis siv kev thaij ntsej muag.

### **Cov duab hauv koob thaij *Flock* puas siv nrhiav tib neeg?**

Cov duab thaij tau tsis siv ntsuam los nrhiav cov tib neeg tsav li cas hauv tsev kawm ntawv thiab tsis siv xaiv ntsuam los soj ib tug neeg qab tas li. Cov no tsis siv nrhiav cov tsheb rau tsoom fwm kev tshawb nrhiav, thiab tsis muaj peev xwm qhia tau cov neeg tsav los cov caij tsheb lub ntsej muag.

Raws UWPD tus cai, tsuas muaj UWPD cov neeg tus puav thiaj nkag tau qhib cov duab no nkaus xwb. Muaj ntaub ntawv tuav tag nrho cov caij qhib tseg thiab ntsuam xyuas kom raws UWPD tus cai thiab cov kev ua.

### **UWPD puas muab tej ntaub ntawv ntes neeg txhaum cai tsav tsheb los lwm yam tub ceev xwm muaj txog cov mejyig, neeg ua num, los xibfwb rau tsoov fwm cov?**

Tsis muab. UWPD tsis muab tej ntaub ntawv los ntawv txog tej kev ntes cov neeg rau tsoom fwm cov tub ceev xwm.

### **Yuav ua li cas yog tub ceev xwm los tsoom fwm los lwm qhov chaw ua haujlwm kom muab ib tug mejyig cov ntaub ntawv? Tsev kawm ntawv puas muab ntaub ntawv rau lawv?**

Tsev kawm ntawv tsuas muab tej ntaub ntawv rau tsoom fwm txog cov mejyig nkaus xwb yog txoj cai lij choj kom yuav tsum muab. Yog ib tug tub ceev xwm kom muab ib tug mejyig cov ntaub ntawv, koj hais rau tias “Kuv tsis muaj cai muab tau cov ntaub ntawv (*I am not authorized to provide the requested information*),” thiab hu rau lub *Office of Legal Affairs*.
